Created specifically for me, SA position advises Senior Vice Chancellor for Academic Affairs on graduate education and coordinates deans for graduate education at twelve USM institutions. Initial projects included 1) coordinating graduate outcomes assessment policies and practices across all USM institutions (including co-organizing "A Convening on Undergraduate and Graduate Learning Outcomes Assessment" (150 attendees); and 2) developing program for graduate students at USM research institutions to teach and mentor undergraduates at USM comprehensive institutions.

## Position: Dean-in-Residence (2016-2017) Council of Graduate Schools

Dean-in-Residence engages in the overall work of the CGS and its ~600 member institutions. DiR works with CGS administrative leadership and staff on research initiatives, grant proposals, and organization of annual and summer meetings (600+ and 250+ attendees), and takes lead on one or two major projects. My projects were 1) sole author of *Useful Knowledge: An Annotated Bibliography of CGS Monographs and Reports*; 2) lead author of *Research Ethics Education for Graduate International Collaborations*, and contributor to revised edition of *Organization and Administration of Graduate Education*. Also represented CGS leadership in meetings on international graduate education at NSF, German Research Foundation, and other venues.

# Position: Associate Provost for Academic Affairs and Dean of the Graduate School (2006-2016) University of Maryland

During my tenure in office, UMD housed >80 doctoral programs and ~150 master's and graduate certificate programs enrolling ~10,800 graduate students. International students represented ~31% of graduate students enrolled, and U.S. minority students ~20%. UMD conferred over 620 doctoral

degrees and 2,000 master's degrees annually. In last NRC rankings, as many as 36 of 56 reviewed programs ranked in top 25, with several in top 10.

Dean of the Graduate School (GS), the chief academic officer for graduate education, reports to Senior Vice President for Academic Affairs and Provost; sits on the University Council of Deans; chairs the University Graduate Council; and leads the GS. Provides *leadership* for academic strategy; *oversight* for policies and standards; administrative *support* and *service* to campus units, colleges, programs, faculty, and students; outreach to prospective students and alumni; and *advocacy* on campus, in broader communities, and in the profession.

During my tenure in office, Dean oversaw team of ~45 faculty administrators and professional staff plus graduate assistants and interns, and managed annual budget of ~\$16M. GS advances campus wide projects for graduate education and graduate students; approves and implements policies recommended by Graduate Council; manages graduate admissions (>25,000 applications annually) and coordinates graduate enrollment; administers ~ \$13M program of fellowships, travel grants, and awards and prizes for students and faculty; awards research/scholarship and creative arts grants to faculty; approves membership to Graduate Faculty; and collaborates as needed with President's Legal Office.

Dean belongs to UMD President's leadership group, comprising vice-presidents and deans, and works at direction of the President's Office on university strategic planning and other broad issues; also sits on UMD Foundation Board of Trustees. Dean also belongs to Provost's Senior Staff, collaborating on policies and practices for all aspects of academic affairs, and sits on Provost's Advisory Council on Academic Planning and Policies, advisory body on coordinated strategic and financial planning.

Dean chaired Provost's Task Force on Professional/Executive Graduate Programs, resulting in policies to ensure that entrepreneurial programs maintain highest levels of academic standards, integrity, and oversight, while remaining responsive, agile, and competitive in the marketplace.

Reviewed graduate admissions policies and practices, revised existing admissions website, with increased interactivity for applicant and immediate online decision notification; reduced average application turn-around time from weeks to less than two days. Researched, negotiated, acquired, and implemented a new campus-wide admissions system (Hobson's *Apply Yourself*).

## **Funding Initiatives**

Developed vision and plan for treating GS resources as tool for leveraging additional resources and influencing strategic behaviors; clarified GS policies and expanded GS practices for cost-sharing partnerships, with emphasis on diversity, interdisciplinary, and international programs and initiatives; created policies and practices for use of Fellowship Tuition Remission to leverage external and internal funding with emphasis on NIH training grants, NSF and other prestigious fellowships, assistantships from off-campus bodies, and substantial private gifts; gained approval of campus Finance Committee for a) increase in application fee to enhance admissions staff, technology, and process, and b) movement of \$4M+ Fellowship Tuition Remission Account to GS budget.

Proposed development plan for graduate education to Office of University Relations, cost-shared a pilot part-time Development Officer, and subsequently created GS Office of Development and Alumni Relations, with full-time Development Officer and full-time Director of Communications.

## **Diversity and International Initiatives**

Created GS Office for Diversity Initiatives, with senior faculty Director, and Graduate Diversity Advisory Committee; collaborated with UMBC and UMB on *PROMISE: Maryland's Alliance for Graduate Education and the Professoriate (NSF AGEP Award),* on successful renewal of initial grant, and on successful proposal for a new grant of \$1.75M; inaugurated colloquia on graduate education for URM undergraduates enrolled at USM's consortium campus, Universities at Shady Grove; inaugurated, administered, and funded McNair Graduate Fellowship Program; initiated and costshared Graduate Assistantship in David C. Driskell Center for the Study of the African Diaspora; sponsored undergraduate McNair Scholars Research Conference and Behavioral and Social Sciences Minority Research Program. UMD was consistently ranked at the top of AAU institutions in doctoral degrees awarded to African Americans.

Collaborated with Office of International Affairs and colleges to promote international graduate degree, research, and student exchange programs, and participated in all international MOUs involving graduate programs and/or students; regularly met with international delegations to explore potential collaborations, and addressed Chinese delegations on U.S graduate administration; worked with School of Public Policy and College of Behavioral and Social Sciences on masters programs in China and Vietnam for government officials, with R.H. Smith School of Business on Executive MBA Program in China, and with College of Agriculture and Natural Resources on many China initiatives; developed intramural cost-sharing program for China Scholarship Council Fellows, and worked with President's Office to create donor-funded *Maryland-China Scholarship Council: Partnership for Doctoral Students*; created cost-shared program of International Graduate Research Fellowships (see http://www.universitas21.com/news/details/193/u21-discover-august-2015).

Dean travelled in Asia and Southeast Asia, North and South America, and Europe and the Middle East to facilitate new joint graduate research and degree programs; finalize pending research and degree program agreements; initiate fellowships for graduate students and exchange programs for graduate faculty and students; recruit outstanding graduate students; broker introductions between UMD deans and program directors and their international counterparts; and engage in other substantive and ceremonial activities.

Assumed responsibility for administering and processing all international graduate admissions (~14, 000 international applications annually), and created and staffed four new positions for international graduate admissions. Created GS Office for International Initiatives and appointed three senior administrators with expertise in Asia, Europe, and Latin America and the Middle East.

Collaborated with President of University of Tübingen in establishing, funding, and administering long-term, multi-project, multidisciplinary training and research initiative in neuroscience, cognitive science, and bioscience; collaborated with University College Cork and with universities in Chile and Argentina on joint graduate student seminar, research, and publication projects; collaborated with Roehampton University on establishing projects in Film Studies and Theater and Performance Studies ; created formal reciprocal agreement in Australia for International Graduate Research Fellowships; participated actively in *Universitas 21*; and developed administrative staff and graduate student leader exchanges with universities in Chile and Macau.

## Reorganization

Executed comprehensive reformulation of GS mission and objectives, full reorganization of GS administrative and academic structures and staff, and complete turnover and enhancement of GS personnel. Streamlined administration, developed system for internal workflow management, and moved all processes online. Through creative budget and personnel management, grew GS staff from 12 persons in 2006 to ~45 persons in 2016.. Conceived and implemented College Associate Deans for Graduate Education, a robust and highly active advisory and liaison body.

# **Communication and Infrastructure**

Oversaw and funded a complete rebuild of GS website; initiated GS use of social media; developed a coherent print presence with multiple brochures, flyers, posters, and other materials; and created three newsletters: weekly newsletter for GS staff; monthly newsletter for campus directors and coordinators of graduate studies; bimonthly newsletter for alumni and other external constituencies.

Oversaw renovation of GS facilities (~\$400k) and second phase renovation and expansion (~\$400k with 15% increase in square footage). Collaborated with other building occupants on renovation of shared spaces (~\$300k).

### **Assessment and Outreach**

Dean served as Institutional Coordinator for the NRC Assessment, chair of Subcommittee on Academic Programs for Middle States CHE PRR, and UMD representative for graduate education to AAU, CGS, Big Ten/CIC, and *Uni21*. Dean convened first ever meeting of USM Graduate Deans and of Graduate Deans and staff from mid-Atlantic public flagship institutions.

# Position: Chair (1998-2006); Acting Chair (1997) Department of English University of Maryland

The English Department, during my tenure in office, employed 225-250 total personnel, including 60 FTE tenure/tenure track faculty, 75-100 non-tenure track faculty, over 80 graduate teaching assistants, a unionized administrative and classified staff of 12 full-time employees, plus a number of graduate administrative assistants. Department was administered by Chair, Associate Chair, and eight Program Directors, and governed through a Departmental Assembly and a network of committees; annual budget totaled ~\$8M.

Department included three programs ranked in the top twenty nationally, including one in the top ten; maintained annual enrollment of over 200 active graduate students and 750 undergraduate majors; provided UMD with ~20,000 classroom seats (and ~50,000 credit hours) annually; and operated a Writing Center providing an annual average of 6000-7000 individual tutoring sessions.

Chair of English was a full-time administrative position with substantial authority for budget, hiring, and other functions. Administrative duties included overseeing faculty Appointment, Promotion, and Tenure processes, faculty and staff merit review processes, and a large hard budget and a constantly shifting soft budget; chairing three major standing committees and appointing ad hoc committees; preparing special funding requests for faculty retention and preventive retention and for program enhancement; facilitating internal and external grant proposals; representing interests of the department in the college, on campus, and in the profession; and managing outreach, advancement, entrepreneurial, and public relations activities. Academic duties included ensuring that Departmental graduate, undergraduate, and general education programs were closely articulated and ensuring that course formats and delivery methods were responsive to resources, pedagogical goals, and "best practices"; and ensuring that Department remained fully committed to diversity in faculty, staff, and student populations and in programming.

Office of the Chair, during my tenure, advanced initiatives such as the first major revision of the undergraduate major in over 15 years; creation of the Jimenez-Porter Writers House, a living-learning community; merger of the Comparative Literature Program with the English Department and incorporation of the PhD in Comparative Literature; incorporation of a Graduate Certificate in Critical Theory; creation of an annual faculty exchange program, and a collaborative graduate student research program, with University of Tübingen; recruitment of 18 tenure track or tenured faculty members; recruitment or retention of nine faculty members of color; creation and management of the Professional Writing Group, a revenue generating entrepreneurial outreach enterprise; preparation of a thorough Internal Review issuing in a 70-page report; management of facilities issues, including collaboration with other "stakeholders" in the rapid development of SW District of campus; lobbying of regents, trustees, and state legislators and Governor for the acquisition of \$34M+ in capital funding for new departmental home in Tawes Hall and seeing all project design

phases through completion; and guiding the Department through a campus budgetary crisis, turning a looming departmental deficit into a budget surplus in the space of two fiscal years.

### Position: Acting Director (2003-2006) Comparative Literature Program University of Maryland

The Comparative Literature Program, than an autonomous academic unit, was primarily a graduate program offering PhD and MA degrees, but also providing undergraduate courses. Over years, the Program had suffered loss of faculty and budget and a consequent loss of academic direction.

Dean of Arts and Humanities appointed me Director with two charges: 1) ensure that the Program was administered properly; and 2) develop a plan for the long-term disposition of the Program. Corresponding responsibilities included: 1) managing annual budget (roughly \$500k) and staff, managing the Vambery Endowment (\$550k), assembling and leading an administrative team, working with faculty to provide robust curricula, and working with enrolled students to insure progress toward degree; and 2) chairing a collegiate committee formed to explore a potential merger of the Program with the English Department and, if recommending positively, with preparing a proposal for approval and implementation. The proposed merger subsequently was approved by UMD, USM, and the Maryland Higher Education Commission.

# Position: Director of Graduate Studies (1994-1998) Department of English University of Maryland

The English Department, during my tenure in the position, served a large and diverse graduate student body in its PhD in English; MA in English; MA in English with a Minor in Language, Rhetoric, and Composition; and MFA in Creative Writing.

Duties of the DGS included student recruitment, advising, and retention; curriculum planning and implementation; strategic planning; oversight of admissions, financial aid, and records; preparation of fellowship proposals; staff management; and liaison with the campus GS. Initiatives during my tenure included departmental review of graduate programs; revision of admissions procedures; preparation of a 130-page report for a campus-wide Graduate Program Review; and expansion of program space and enhancement of facilities. African American graduate student enrollment in English represented 46% of the college total and 5.2% of the campus total.

# Position: Director (1990-2006) The Bebe Koch Petrou Lectures University of Maryland

Direction of the Bebe Koch Petrou Lectures, the English Department's endowed lecture series, included administering the endowment, securing state matching funds, serving as liaison with the Petrou Foundation, and organizing and managing over 25 Petrou Lectures.

# Position: Publications Coordinator (1976-1978) Center for 20<sup>th</sup> Century Studies, UWM

An interdisciplinary humanities research center, the Center for 20<sup>th</sup> Century Studies (now Center for 21<sup>st</sup> Century Studies) focused on the study of contemporary cultures in an international framework and the development of new models in cultural theory and history. As Publications Coordinator, I worked with the Director on initiating the book series, Theories of Contemporary Culture (which then continued for 24 years) and on editing its first volume, *Performance in Postmodern Culture*.
